A meeting of the Georgia State Board of Architects and Interior Designers was held Friday, March 25, 2005, via telephone conference call at the Office of the Executive Director, Professional Licensing Boards Division, 237 Coliseum Drive, Macon, Georgia.

Ms. Puckett made a motion to enter into Executive Session in accordance with O.C.G.A.43-1-2(k) and 43-1-19(h) to discuss the petition for waiver of Board Rule 50-10-.02 (c) (d) from Jan O. Zuccarello. Ms. Love-Stanley seconded the motion. Voting in favor of the motion were those members present who included Board Members Bolton, Love-Stanley, Maschke, McRae, Mehserle, Puckett, and Smith. The Board concluded Executive Session in order to vote on these matters and to continue with the public session.

Jan O. Zuccarello: The Board considered a petition for waiver of Board Rule 50-10-.02 (c)(d) in accordance with O.C.G.A. 50-13-9.1. Ms. Puckett made a motion to **deny** the request for waiver. Ms. McRae seconded the motion. The motion carried unanimously. The Board noted that an official college transcript had not been previously submitted. Upon receipt of an official transcript showing that the educational requirements have been met, the Board will again consider the application for registration.
