**Written Correspondences**

**RA010588:** The Board reviewed correspondence from this licensee and directed staff to send a response that the Board appreciates his input and understands his position.

**Jorge Bazan:** The Board reviewed correspondence from Mr. Bazan requesting information regarding a business that he is starting and the type work that will be performed. The Board directed staff to respond by stating clearly that he cannot list the firm name as FLU(x) Architecture + Design, LLC because it misleads the public and thus violates the law 43-4-17(a). In regard to the office building, the Board does not feel it has adequate information to respond properly. In regards to the Design, the Board recommends that he seek legal advice and be advised that all interior design (structure) must be performed by a registered person.

**David Erickson:** The Board reviewed correspondence from Mr. Erickson requesting clarification of Georgia Statute 43-4-14(b)(3) regarding projects that do not require architectural licensure. The Board directed staff to respond by referring him back to the law where it states that licensure is required.
