The Georgia State Board of Athletic Trainers met on September 28, 2007 via Conference Call.

**Mr. Hoff established that a quorum was present, and called the meeting to order at 8:18 am.**

**Mr. Hoff moved, Dr. Malone seconded and the Board voted to enter into Executive Session in accordance with O.C.G.A. §43-1-2(k)(1)(2), O.C.G.A. §43-1-19(H)(2)&(4) and O.C.G.A. §43-1-2(k)(4) to deliberate on Applications and to receive information on Applications. Voting in favor of the motion were those present who included Board Member Treadway. The Board concluded Executive Session in order to vote on these matters and to continue with the public session.**
