Mr. Hoff established that a quorum was present and the meeting that was called to order at 1:01 p.m.

Executive Director's Report:

• **Interested Parties List:**

Recently, the Professional Licensing Boards Division of the Secretary of State's Office updated their software regarding the Interested Parties list maintained by the Board. The Interested Parties list is a way for the Board to notify licensees, as well as interested parties and associations, of current rules being proposed by the Board. Subscribers of this list are sent electronic notifications each time a proposed rule is being considered by the Board. Even if you were previously subscribed to receive such notifications, you will need to complete the subscription process again in order to continue receiving notifications from the Board.

Graduate Assistants and Unlicensed Practice:

- It was determined by a majority of the Board members that an individual who has graduated with an Athletic Trainers degree and has passed the exam and is working under a contract for compensation should be licensed. It was also noted that tuition credit would qualify as financial compensation.

Miscellaneous Board Discussion Items:

- HB 284- Return to Play Act of 2013 was posted for Board member review. Board rules and the Board's Scope of Practice (O.C.G.A. § 43-28) will be reviewed to see if any changes should be made as a result of HB 284.
- The Volunteer in Health Care Continuing Education Reporting Form was presented. This form can be used by licensees to record continuing education hours for volunteer services as allowed under Board Policy III.
