

<p>Georgia Auctioneer Commission Board Meeting April 20, 2009</p>

A public hearing was conducted by the Georgia Auctioneers Commission at 10:00 a.m. at 237 Coliseum Drive, Macon, GA, for the purpose of hearing an appeal by an applicant for licensure. Paul Brower moved, Norman Echols seconded, and the Commission voted to grant licensure to Howard Daniel Coleman by public consent order, placing the license on probation for 2 years and requiring periodic reporting to the Commission of his activities.
