Dr. Mathiak established a quorum of the Board and called the meeting to order at 8:31 a.m.

**Rule Waiver Request – Nazir A. Mousselli**

Dr. Wren motioned, Dr. Krantz seconded and the Board voted unanimously in favor of the motion to deny the rule waiver based on inability to substantiate a hardship, rescind the previous motion and refer to the Attorney General's office to issue a Public Consent Agreement for Reinstatement of Licensure with a \$1000 fine for unlicensed practice from 12/2012 to 12/2014 and two (2) years of probation, and grant the Attorney General office authority to adjust the standard language within the order to most accurately convey the respondent's circumstances.

**Dr. Wren motioned, Dr. Krantz seconded, and the Board voted to enter into Executive Session in accordance with O.C.G.A. § 43-1-2(k) (1) (2), O.C.G.A. § 50-14-2(1), O.C.G.A. § 43-1-2(k) (4), O.C.G.A. § 43-1-19 (h) (2) & (4) to receive and review information pertaining to applications, complaints, and to receive the Assistant Attorney General's and Investigative Committee reports. Voting in favor of the motion were those present who included Dr. Mathiak, Dr. Wren, Dr. Krantz, Dr. Krzemien and Ms. Campbell.**

**At the conclusion of Executive Session on Wednesday, September 2, 2015, Dr. Mathiak declared the meeting to be "open" pursuant to the Open and Public Meeting Act O.C.G.A. § 50-14-1 et seq. No votes were obtained during Executive Session.**
