**2016 Board Member Elections**

**1) Board Chair**

Dr. Krantz motioned, Dr. Krzemien seconded and the Board voted unanimously in favor of the motion to nominate Dr. Mary Watkins as the Board's Chair.

Dr. Watkins motioned, Dr. Wren seconded and the Board voted unanimously in favor of the motion to nominate Dr. Andrew Krantz as the Board's Vice Chair.

**3) Investigative Committee**

Dr. Wren motioned, Dr. Krzemien seconded and the Board voted unanimously in favor of the motion to nominate Dr. Mary Watkins and Dr. Andrew Krantz as the Board's Investigative Committee.

**4) Continuing Education Cognizant**

Dr. Watkins motioned, Dr. Krantz seconded and the Board voted unanimously in favor of the motion to nominate Dr. David Wren as the Board's Continuing Education Cognizant.

**Investigative Committee Meeting Dates & Times**
