  - The Board discussed with Susan Fort, Executive Director, NASW and Gale Macke, Executive Director, LPCA, about contacting the legislators and request that they revise the wording in the bill to reflect Licensed Professional Counselors, Marriage and Family Therapists, as well as, Licensed Clinical Social Workers.
2. Ms. Beard informed the Board that they would need to decide whether or not they would like to repost Rule 135-6-.03 and Rule 135-6-.04 as previously posted or make revisions.
