William Quarterman, Chair, established a quorum of the Board was present and called the Board meeting to order at 9:16 a.m.

Minutes:

Bacon motioned, Harwell seconded, and the Board voted to approve the following minutes as amended. None opposed, motion carried.

Executive Director's Report:

1. Mr. Zimmerman informed the Board that the IT Department was currently working diligently on solving the issues with the new computer database that has delayed the online renewal process. Mr. Zimmerman stated the problems will be resolved as soon as possible.
2. Mr. Zimmerman informed the Board that in the current renewal cycle, the status will remain "active" of those licensees randomly selected for a CE audit until the September 30, 2010 expiration date.

3. Mr. Zimmerman informed the Board that NBCC is now offering the national exam two weeks out of each month; this will delay in the Board receiving the score reports by about two weeks.
4. Mr. Zimmerman notified the Board that around in mid May, when the new licensure database was installed, a number of license pocket cards were issued with an incorrect expiration date. The error has been corrected and a request has been sent to all licensees notifying them of the error, requesting they return the pocket cards to the Board office within 10 business days. A new license pocket card was also issued to each with the correct expiration date.

Harwell motioned, Bacon seconded, and the Board voted to accept the Executive Director's report as presented. None opposed, motion carried.

Board Policy:

Administrative Issuance of Master Social Worker Applications:

Harwell motioned, Coale seconded, and the Board voted to allow the administrative staff the authority to issue MSW licenses administratively between scheduled Board meetings, as long as all requirements are met. For applicants applying for licensure from another state, staff must verify that the education requirements are satisfactory. Board will ratify the list of administratively issued license on the next scheduled meeting date. None opposed, motion carried.

Sanctions and Fine Scale for Unlicensed Practice:

Practicing without a valid Georgia license may be grounds, within the Boards discretion, for disciplinary sanctions, including but not limited to, the sanctions provided below.

a. Possible fines to be considered (circumstances may be taken into account in varying the fine amount and/or sanctions and is within the Boards discretion):

1. Practice over one month but not exceeding three months: fine of \$100.00 per month;
2. Practice over 3 months but not exceeding one year: fine of \$500.00;
3. Practice over one year but not exceeding two years: fine of \$750.00;
4. Practice over two years but not exceeding three years: fine of \$1,000.00;
5. Practice over three years: fine of \$1,000.00 plus an additional fine of \$100.00 for each month worked, or portion thereof, over three years not to exceed \$5,000.00.

Harwell motioned, Bacon seconded, and the Board voted to accept the unlicensed practice fine scale policy as presented. None opposed, motion carried.

Schrader motioned, Harwell seconded, and the Board voted to enter into Executive Session in accordance with O.C.G.A. § 43-1-2(k) (1) (2), O.C.G.A. § 50-14-2(1), O.C.G.A. § 43-1-2(k) (4), O.C.G.A. § 43-1-19 (h) (2) & (4) to receive and review information pertaining to Applications, receive the Attorney General's, Cognizant, and Professional Practice Reports. Voting in favor of the motion were those present who included Board members: Quarterman, Schrader, Ligon, Coale, Harwell, Barker, Mixon, Perryman and Bacon.
