Approval of Executive Session Minutes:

A motion was made by Mr. Lyons, seconded by Mr. Weaver, and the Board voted unanimously to accept the following recommendations involving investigative cases (Ken Davis recused himself from voting):

Board Office:

CA130110- This case involves allegations of unlicensed practice. As a result of lack of service of Notice of Hearing, the Board voted to close the case with no action. Ken Davis recused from voting.

CA130005, Wayne, Harvey- This case involves allegations of unlicensed practice. As a result of hearing conducted, the Board voted to accept the order of insufficient evidence presented at the hearing to issue a Cease and Desist order and close the case. Ken Davis recused from voting.

CA140012- Close with no action.

CA140035- Close due to duplicate complaint case number.

CA140040- Close due to complainant unresponsive.

Investigations:

CA140016- This case involves allegations of assisting unlicensed practices. The Board voted to refer **respondent 1** to the AG for a consent order for assisting unlicensed practices assessing a \$1000.00 fine and 24 months of probation; refer **respondent 2** to the AG to obtain a C & D or schedule an hearing.

CA140028- Martin Littleton, Alpharetta-The Board voted to accept the Cease and Desist order and close the case. The Board voted to refer respondent 2 to the AG for a consent order for assisting unlicensed practices.

CA130051- Refer respondent 1- This case involves allegations of substandard work and failing to obtain permit. The Board voted to refer **respondent 1**(license holder for the company at the time of violation) to the Attorney General's office for a consent order for substandard work assessing a \$1000.00 fine, obtain and provide to the board a copy of both the permit and inspection, restitution to the complainant in the amount of \$89.00 and 4 hours of additional continuing education on codes OR 24 months of probation. The Board voted to refer **respondent 2** to the Attorney General's office for a consent order for substandard work stating that that licensee must obtain 4 hours of additional continuing education classes on codes or 24 months of probation.

CA140027- The Board voted to close due to complainant unresponsive.

CA130123- This case involves allegations of unlicensed practice. The Board voted to refer **respondent 1** to the Attorney General to obtain a Cease and Desist Order or schedule a hearing and to refer **respondent 2** to investigations.

CA140023- The Board voted to close and refer to the Plumbing Board.

CA140041-The Board voted to close due to **respondent 1** cannot be located and **respondent 2** is not connected to **respondent 1**.

CA140058- This case involves allegations of assisting unlicensed practice. The Board voted to refer to Attorney General's office to seek revocation of license and to notify Florida Board of such.

Legal:

CA140062- Kirk Anthony Holman- Board voted to accept consent order for renewal with criminal conviction placing the license on probation for 24 months and close. Docket no.2014-1623.

Assistant Attorney General:

CA120144- Luther William Kelley, III- The Board voted to accept initial decision from hearing at OSHA revoking CN license due to extensive non-reported criminal history and close. Docket no. 1458952-117.

CA130104- Edward Sidney Fritts- The Board voted to accept the Cease and Desist Order and close. Docket no. 2014-1603.

CA120018- Barry G. Lowery- The Board voted to accept consent order for substandard work placing the license on probation for 2 years and completion of an additional 8 hours of continuing education classes on package unit installation within 6 months of docketed order and close. Docket no.2014-1656.

CA140039- Georgio Grasso- The Board voted to accept the Cease and Desist Order and to close. Docket no. 2014-1655. The Board also voted to close with no action on **respondent 2**.

CA110061- Kelvin Griffen-The Board voted to accept consent order for 4 violations of previously issued Cease and Desist Order. Docket no. 2003-0941. The Board voted to close case with no further action for respondent failing to remit all but \$375.00 of assessed fine.

CA130014- Ricky Harper-The Board voted to accept the C& D and close.

CA120017-This case involves allegations of unlicensed practices. The Board voted to close as a result of Attorney General's memorandum of insufficient evidence to proceed to hearing.

CA120128- This case involves allegations of violating previously issued C & D. The Board voted to close as a result of Attorney General's memorandum of insufficient evidence.

CA120002-This case involves allegations of failing to honor warranty. The Board voted to close due to age of complaint and investigative report of inconclusive evidence.

CA130042-This case involves allegations of unprofessional conduct. The Board voted to close due to license has lapsed and flag license in case of reinstatement application. Reopen case if applies for reinstatement.

Other Business:

Southwark Metal Manufacturing Company- The Board voted to approve the courses offered by James J. Mayer of Southwark Metal Manufacturing Company. Mr. Lyons moved and Mr. Lenaeus seconded, and the motion carried unanimously.

RectorSeal- The Board voted to approve courses offer by James Bowman of RectorSeal. Mr. Lyons moved and Mr. Lenaeus seconded, the motion carried unanimously.
