Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to enter Executive Session in accordance with O.C.G.A. c43-1-2(k) and 43-1-9(h) to deliberate on application and enforcement matters and to review information on applications and investigate reports. Voting in favor of the motion were Winston Strickland, Virgil Ergle, and Lutha Crump.

School/Inspections Report

Dianne Yawn's report included the following:

Submitted report of unlicensed salons referred to Enforcement.

Informed board members of a report from an Inspector of verbal abuse from a shop owner during an inspection. Ms. Yawn informed the board that administration will request an Enforcement Agent or local Law Enforcement person accompany inspectors when they must inspect shops/salons where confrontational encounters are anticipated.

Jeff Clements presented reports regarding applicants with convictions.

The board concluded Executive Session in order to vote on these matters and to continue public session.

Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to approve the referral of the following unlicensed salons to Enforcement for Cease and Desist Orders:
EC/SandySPrings, WBS/Bainbridge.

Lutha Crump moved, Winston Strickland seconded, and the board voted unanimously that when Inspectors experience confrontational encounters during routine inspections of salons, a letter of concern be sent to the owner of the salon.

Board members discussed the scoring procedure for master barber examination with JBJ/masbarber exam and encouraged him to apply to retake the examination.

Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to close Enforcement cases BAR050029, BAR050030, BAR050031, and BAR050032.

Lutha Crump moved, Winston Strickland seconded, and the board voted unanimously to accept signed Cease and Desist Orders for the following:

Winston Strickland moved, Lutha Crump seconded, and the board voted unanimously to approve the application of HDD/barberappr attaching a consent order that the license is placed on probation until February 7, 2008 and the applicant must immediately report any future arrests or convictions to the board.

Lutha Crump moved, Virgil Ergle seconded, and the board voted unanimously to approve the application of JDS/masbarberexam attaching a consent order that the license is placed on probation for two year from the date o licensure and the licensee must immediately report any future arrests or convictions to the board.

Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to approve the application of AW/barberapprentice attaching a consent order that the license is placed on probation until November 1, 2009 and the licensee must immediately report any future arrests or convictions to the board.

Lutha Crump moved, Winston Strickland seconded, and the board voted unanimously to approve the application of PS/endorsement attaching a consent order that the license is placed on probation for two years and the licensee must immediately report any future arrests or convictions to the board.

Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to approve the application of DB/masbarberreinstate attaching a consent order that the license be suspended for three months the placed on probation until March, 2009 and the licensee must immediately report any future arrests or convictions to the board.

Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to deny the application of TE/barber appr.

Virgil Ergle moved, Lutha Crump seconded, and the board voted unanimously to approve the application of PC/endorsement attaching a consent order that the license is placed on probation until September 2006 and the licensee must immediately report any future arrests or convictions to the board.
