An Administrative Appeal Hearing was conducted regarding the licensure of James Willis. The hearing officer placed the board in executive session to deliberate on the matter.

The Board concluded executive session.

The Board voted unanimously voted to rescind its previous decision to deny reinstatement of the Master Barbers License of James Willis, and instead decided to approve the reinstatement of his license attaching a consent order that the license is on probation to run concurrent with the criminal probation and two years thereafter, and applicant is assessed a fine of \$500.00 that must be paid within six months of his release from transitional center.

Virgil Ergle moved, Charles Manning, and the Board voted unanimously to enter Executive Session in accordance with O.C.G.A. § 43-1-2 (k) and 43-1-9(h) to deliberate on applications, enforcement matters and to review information on applications and investigate reports. Voting in favor of the motion were Winston Strickland, Lorena Barrios, David Jones and Lutha Crump.
