Martha Harris called the meeting to order at 10:00.

Kay Kendrick moved, Evelyn Reid seconded and the Board voted unanimously to approve the minutes from the June 07, 2006 meeting

Kay Kendrick moved, Betty Carlisle seconded and the Board voted unanimously to enter into Executive Session in accordance with O.C.G.A § 43-1-2(k) and 43-1-9(h) to deliberate on applications, enforcement matters and to review information on applications and investigate reports. Voting in favor of the motion were Martha Harris, John Siggers, Cynthia Stein, Don Westbrook, and Evelyn Reid.

The Board concluded Executive Session in order to vote on these matters and to continue public session.

Old Business:

Martha Harris called for a discussion of rule revisions to post for 130-3-.02, 130-3-.03, 130-3-.10, 130-3-.11 and 130-3-.12. Also discussed was the Board needed to create a Hair Design Instructors curriculum.

Kay Kendrick moved, Evelyn Reid seconded and the Board voted unanimously for the executive director to notify D.L. Roope, Inc. that the use of marcel iron is required at all master cosmetology and hair design exam.

Kay Kendrick moved, Betty Carlisle seconded and the Board voted unanimously to change the wording in the instructor's curriculum from "a minimum of" to "within."

John Siggers moved, Don Westbrook seconded and the Board voted unanimously that all hair hours must be completed for any hair design applicants currently enrolled in a master cosmetology training curriculum and that these same applicants will lose esthetician and nail technician hours.

John Siggers moved, Don Westbrook seconded and the Board voted unanimously that schools or apprentice trainers may transfer hours of students/apprentices from the master cosmetology curriculum to the esthetic and/or nail technician curriculum to meet curriculum requirements towards licensure.

The Board instructed the Executive Director to add space for square footage on salon applications lease or bill of sale if applicant is purchasing an existing salon.

New Business:

Kay Kendrick moved, Evelyn Reid seconded and the Board voted unanimously that the Business Regulation and Inspections Supervisor inspect Osbourne Beauty Academy at Belmont Hills located in Smyrna and a Salon located in the Wal-mart Shopping Center in Thompson.

Don Westbrook moved, John Siggers seconded and the Board voted unanimously that the hours obtained in the hair portion of the Cosmetology Curriculum may be accepted to qualify for the Hair Designer examination.

John Siggers moved, Evelyn Reid seconded and the Board voted unanimously to accept the additional dates of September 12, 2006 for the Estheticians exam and September 20, 2006 for Nail Technician exam.

John Siggers moved, Betty Carlisle seconded and the Board voted unanimously to ratify the report for the following applications that were reviewed by committee on July 06, 2006:
