The Board concluded Executive Session in order to vote on these matters and to continue with public session.

Virgil Ergle moved, Lutha Crump seconded, and the board voted by majority to accept from MD/BAPP 1050 late apprentice hours and allow a second apprentice license. Winston Strickland abstained from the vote.

Lutha Crump moved, Virgil Ergle seconded and the Board voted unanimously to rescind its previous decision for TC/MASBARB/ENDORS and to now deny endorsement but allow to sit for the exam.

Winston Strickland moved, Virgil Ergle seconded, and the Board voted unanimously to approve the application of TC/LBS/BRSH attaching a consent order that the license is on probation for four years and the licensee must immediately report any future arrests or convictions.

Winston Strickland moved, David Jones seconded, and the Board voted unanimously to approve the application of BI/MASBAR/REN attaching a consent order that the license is on probation concurrent with the criminal probation and the licensee must immediately report any future arrests or convictions.

Winston Strickland moved, Virgil Ergle seconded, and the Board voted unanimously to approve the application of BF/BAPP without discipline and to issue the license.
