4. Election of Officers for Year 2007:

Charles Manning moved, Winston Strickland seconded, and the Board voted unanimously that officers be retained as David Jones, Chairman and Virgil Ertle as Vice-Chairman.

Business Regulation and Inspection Report

Annie Plummer included the following:

1. Flava Beauty Salon and Grips Grooming & Barbering had been re-inspected per the Boards request. Ms. Plummer advised the Board of the licensing status of each salon/shop.
2. Ms. Plummer presented 3 Voluntary Cease and Desists Orders for unlicensed barbershops.
3. Ms. Plummer presented 10 Voluntary Cease and Desists Orders for unlicensed individuals.
4. Ms. Plummer presented Ms. Amanda Manigault, owner, as a new school applicant, Amanda's Barber Arts Institute.

Charles Manning moved, Lorena Barrios seconded, and the Board voted unanimously that once owner makes changes as indicated by the Board, the revised plans are reviewed and approved and passes the inspection by the Board member, then Ms. Plummer can authorize the school to open.

Winston Strickland moved, Virgil Ertle seconded, and the Board voted unanimously to enter Executive Session in accordance with O.C.G.A. χ 43-1-2(k) and 43-1-9(h) to deliberate on applications and enforcement matters and to receive information on applications and investigative reports.

Voting in favor of the motion were, Charles Manning, Lutha Crump and Lorena Barrios,

The Board concluded Executive Session in order to vote on these matters and to continue with public session.

Virgil Ergle moved, Winston Strickland seconded, and the board voted unanimously to deny the request of JM/ba to accept late apprentice hours to qualify to sit for exam. Licensee must complete required apprentice hours within 18 months to qualify to sit for exam as no more apprentice licenses will be issued.

Winston Strickland moved, Lorena Barrios seconded, and the Board voted unanimously to approve the application of VD/ba attaching a consent order that the license is placed on probation until August 28, 2008, and the licensee must immediately report any future arrests or convictions to the Board.

Virgil Ergle moved, Winston Strickland seconded, and the Board voted unanimously for MJS/b/end. to appear at the February 2007 meeting.

Winston Strickland moved, Lorena Barrios seconded, and the Board voted unanimously for FTjr/ba to appear at the February 2007 meeting.

Virgil Ergle moved, Winston Strickland seconded, and the Board voted unanimously to approve the application of ALS/ba attaching a consent order that the license is on probation concurrent with the criminal probation and the licensee must immediately report any future arrests or convictions.

Winston Strickland moved, Virgil Ergle seconded, and the Board voted unanimously to approve the application of AHW/hq/brsh but not issue license until suspension is removed from his master license and to attach a consent order that the license is on probation concurrent with his criminal probation and licensee must immediately report any future arrests or convictions.
