## **Business Regulation and Inspection Report**

Annie Plummer included the following:

1. The Preliminary and final inspection of Amanda's Art of Barbering has been conducted and is now open.
2. Ms. Plummer presented 4 Voluntary Cease and Desists Orders for unlicensed barbershops.
3. Ms. Plummer presented 6 Voluntary Cease and Desists Orders for unlicensed individuals.

Ms. Plummer presented the Board with 4 Voluntary Cease and Desists Orders for unlicensed individuals who had refused to sign and ask the Board for their directive.

Ms. Plummer asked the Board to clarify if it is permissible for Barbers to wax or arch eyebrows. The Board answered "There is nothing in the law that specifically states they cannot perform that service."

**An Administrative Appeal Hearing was conducted regarding the citation issued to Detrick Rowser, d/b/a Wayne'z World Barber Shop. The hearing officer placed the board in executive session to deliberate on the matter**

**The Board concluded Executive Session in order to vote on these matters and to continue with public session.**

**The Board voted unanimously** to uphold the initial decision of the OSAH hearing affirming the citation to be paid by Detrick Rowser, d/b/a Wayne'z World Barber Shop.

**Lorena Barrios moved, Lutha Crump seconded, and the Board voted unanimously to enter Executive Session in accordance with O.C.G.A.  $\chi$ 43-1-2(k) and 43-1-9(h) to deliberate on applications and enforcement matters and to receive information on applications and investigative reports. Voting in favor of the motion were, Charles Manning, Winston Strickland and Virgil Ergle.**

**The Board concluded Executive Session in order to vote on these matters and to continue with public session.**

**Winston Strickland moved, Virgil Ergle seconded and the Board voted unanimously** to reinspect the shops that employed the following unlicensed individuals and refer to enforcement if the individuals are found to still be performing services: ABG, AW, CU and SH.

**Virgil Ergle moved, Winston Strickland seconded and the Board voted unanimously** to dismiss the voluntary cease and desists orders of the now licensed shops of Off the Top Beauty and Barber Shop and Platinum Styles and Cuts.

**Winston Strickland moved, Charles Manning seconded, and the Board voted unanimously** to deny the application of DKF/BAPP based on the authority given the board in O.C. G. A § 43-1-19.
