**Evelyn Reid moved, Michelle Turley seconded, and the Board voted unanimously** to send letters and a copy of 130-3-.01 rule revisions to all Georgia schools advising them that they must be in compliance with all revisions by June 01, 2008.

**Kay Kendrick moved, Evelyn Reid seconded, and the Board voted unanimously** to approve the request of Brigg Zimmerman, Executive Director, State of Georgia Massage Therapy Board, to receive a copy of the school application of Georgia Beauty School and share any other requested information.

**Wanda Brooks moved, Michelle Turley seconded, and the Board voted unanimously** to refer to the assistant attorney general the high school diploma from Prevention Plus for a memorandum of whether or not it is an accredited high school diploma.

**Kay Kendrick moved, Michelle Turley seconded, and the Board voted unanimously** to invite NHTH to the November board meeting.

**Michelle Turley moved, Wanda Brooks seconded, and the Board voted unanimously** to send a letter to Eddie Jones, Executive Director, South Carolina Board of Cosmetology, advising him of an esthetician school possibly giving out wrong information about licensing requirements in the State of Georgia.

**Kay Kendrick moved, John Siggers seconded, and the Board voted unanimously** to invite a representative from the Department of Technical Adult Education to the November meeting to discuss the current continuing education laws.

**Rebecca Adams**, Assistant Attorney General, provided everyone with a memorandum from Shawn LaGrua, Inspector General, advising them with the results of the recent sting operation.

**Rebecca Adams**, Assistant Attorney General, advised the board that if an applicant is denied a license based merely on qualifications (or lack thereof) they are NOT entitled to a hearing at OSAH, but they may come before the board to plead their case. If an applicant is denied a license based on **disciplinary issues e.g., past felony convictions**, they may be entitled to an OSAH hearing. IF that applicant chooses to appear before the board, they should NOT appear before the entire board but before the cognizant member only. This avoids "tainting" the board if the case comes back before them on an agency review following an OSAH hearing.

**Kay Kendrick**, Board member, distributed print-outs of legislative bills from various states with emphasis on how other states are addressing the issue of mobile salons.

### **Old Business**

Lawanda Bowman, owner of Lawanda Bowman RV, met with the board to address mobile salons. The Board again advised Ms. Bowman of the violation(s) of operating a mobile salon and suggested modification to accommodate both state laws and the citizens she serves. The Board also advised Ms. Bowman that they look forward to working with her regarding legislative issues to address the situation.

**Michelle Turley moved, Evelyn Reid seconded, and the Board voted unanimously** to approve the following dates for the Y2008 cosmetology board meetings: Jan. 09, 2008, Feb. 06, 2008, March 05, 2008, April 02, 2008, May 07, 2008, June 04, 2008, July 02, 2008, Aug. 06, 2008, Sept. 10, 2008, Oct. 01, 2008 Nov. 05, 2008, and Dec. 03, 2008.

**Eleanor Surrency**, Executive Director, advised the Board members of the Secretary of State's position on providing name badges to them.

**Kay Kendrick moved, Evelyn Reid seconded, and the Board voted unanimously** to have inspectors hand deliver to business licensing entities a letter concerning NOT licensing mobile salons.

**Eleanor Surrency**, Executive Director, requested the Board members refer to O.C. G. A § 43-10-12, paragraph 7 and advised that the hair designer instructor needs to be included under the instructor renewal section.

**Michelle Turley moved, Wanda Brooks seconded, and the Board voted unanimously** to close complaint case number COS080142.

**Kay Kendrick moved, Michelle Turley seconded, and the Board voted unanimously** that a response letter concerning COS080142 be sent from the Secretary of State's office to representative Amos Amerson.

**Kay Kendrick moved, Michelle Turley seconded, and the Board voted unanimously** to approve the following actions on applications, request, etc:
