**Assistant Attorney General's Presentations**

Janet Jackson informed the Board that Assistant Attorney General Daniel Stowe has been assigned as counsel to the Barber and Cosmetology Board.

Janet Jackson submitted a status and activity report of citations cases referred to the State Attorney General's office.

Janet Jackson presented a proposal for the Board's consideration which calls for the Board to conduct citation hearings rather than referring cases to the Attorney General for OSAH hearings.

The Legal Services Attorneys briefly reviewed the General Provisions list of various sanctions that the Boards may utilize when disciplining an applicant or licensee.

Staff members from the examination department presented the Y2007 Barber Examination Report.

**Winston Strickland moved, Virgil Ergle seconded, and the Board voted unanimously to enter Executive Session in accordance with O.C.G.A.  $\gamma$ 43-1-2(k) and 43-1-9(h) to deliberate on applications and enforcement matters and to receive information on applications and investigative reports.
