4. Report of Counts by Profession:

Eleanor Surrency informed the Board that there were 11,179 Cosmetology Salons in Georgia, and stated that there were over 12,000 including nails.

Eleanor Surrency discussed a letter addressed to the board from Dinh Tran requesting to become a translator for the board. The information was reviewed: **Michelle Turley moved, Kay Kendrick seconded, and the Board voted unanimously** to add Dinh Tran to the list of translators.

CE Waivers and Mobile Salons – Eleanor Surrency read letters from two licensees regarding CE waivers, and a letter regarding a mobile hair cutting license. Daniel Strowe stated that he had a memo regarding the Mobile Salon issue, and stated that the Board does not have the authority to license Mobile Salons at this time. **Wanda Brooks moved, Evelyn Reid seconded, and the Board voted unanimously** to request that Eleanor Surrency respond to the person she received the letter from regarding Mobile hair cutting license expressing thanks for her interest and concerns.

Betty Carlisle moved, Evelyn Reid seconded, and the Board voted unanimously to enter into Executive Session in accordance with O.C.G.A § 43-1-2(k) and 43-1-9(h) to deliberate on applications, enforcement matters and to review information on applications, Administrative Requests, and investigate reports. Voting in favor of the motion were: John Siggers, Wanda Brooks, Kay Kendrick, Cynthia Stein, Betty Carlisle, Evelyn Reid, Michelle Turley, and Martha Harris.

The Board concluded Executive Session in order to vote on these matters and to continue public session.

Kay Kendrick moved, Wanda Brooks seconded and the Board voted unanimously to grant a CE waiver to SKT. Old Business:

Michelle Turley reported on the conference in San Diego that she attended. She stated that the teaching was on "How To Stay Within Your Scope Of Practice".

Kay Kendrick, referring to the minutes of the last meeting, asked had the re-inspection been done for the ICBC/COSC. Eleanor Surrency stated that Ms. Plummer was performing the re-inspection, and has received the board's referral.

Kay Kendrick, referring to the minutes of the last meeting, asked about the status of the reciprocity request from the Netherlands. Eleanor Surrency stated that the person was unable to provide the required information from the Netherlands.

Kay Kendrick, referring to the minutes of the last meeting, stated that there were nine cases that required a consent agreement be signed, and asked had this been done. Angela Price stated that Legal Services reports on the consent agreements. Kay Kendrick stated that at the next meeting, Ms. Surrency's report should reflect whether this has been done, and the secretary's report should state that a letter was sent to Legal. Ms. Surrency stated that Legal provide follow-up monthly in their report of consent agreement return for the Board to accept and a list to dismiss based on no response from the applicant.

Kay Kendrick, referring to the minutes of the last meeting, asked about ASC/School. Eighty-five (85) percent of the required training hours and one year of documented work experience in lieu of the additional training hours shall be required for Nail Technicians; Eighty-five (85) percent of the required training hours and two years of documented work experience in lieu of additional training hours shall be required for Estheticians, Hair Designers, and Cosmetologist. Reciprocity applicants, who passed the written and practical examination for licensure without the number of training hours required by Georgia, must obtain the hours from an approved Georgia school before reciprocity may be extended.*

Kay Kendrick moved, Evelyn Reid seconded and the Board voted unanimously to invite TAT/master to appear at the June 2008 board meeting to discuss the board's concerns of apprentice TBN.

Betty Carlisle moved, Evelyn Reid seconded and the Board voted unanimously to send a letter to ET, who was scheduled to appear before the board, expressing the

Board's sincere regrets of not being able to talk with her before she had to leave. Eleanor Surrency stated that she would call ET, and that a letter would be sent to her.

Betty Carlisle moved, Evelyn Reid seconded, and the Board voted unanimously to accept the Applicant's Request for Reconsideration for KC/Master-initial.

Michelle Turley moved, Wanda Brooks seconded, and the Board voted unanimously to close the application files recommended by Legal for the following:

1. TBN – nail tech apprentice
2. AB – apprentice

Assistant Attorney General's Report

Daniel Stowe, Assistant Attorney General, discussed Mobile Salons.

Daniel Stowe distributed his report of closed cases, and stated that he will be going to hearings on June 19th for the Cosmetology Board.

Daniel Stowe discussed removing Brazilian Wax from the salon names. He suggested amending the letter to give notice that the name included misleading words, and stated that if we administratively change the license, the shop is going to differ. The shops have the right to choose their own name. The Board may review and advise on a business name prior to the issuance of a license to insure the name reflects the business intent for Cosmetology services. Once the salon license is issued the Board should not change the name administratively without notification to the owner and allowing a period of approximately 30 days for the change to be effective. The change should be of no cost to the owner if requested by the Board. **Martha Harris, Chair**, stated that Brazilian Wax can be left in but barber can be misleading because it leads the public to think it is a Barber Shop. Brazilian wax reflects the product name.

Daniel Stowe discussed the memo regarding revoking licenses. He stated that it has to be an active license in order to pursue. We cannot pursue a lapsed license that becomes automatically a revoked license, but we can issue a C&D.

Daniel Stowe stated that he could not find where JH and JA are accredited schools.

Angela Price distributed information she received in the mail regarding purchasing of Federal Labor Law posters.

Kay Kendrick moved, Michelle Turley seconded, and the Board voted unanimously for TBS/School to set up preliminary and final inspection.

Kay Kendrick moved, Wanda Brooks seconded, and the Board voted unanimously that salons containing the word Brazilian Wax in their name will not be required to remove the wording.

No further business was conducted. The meeting adjourned at 2:45 p.m.
