David Jones established a quorum was present, and called the meeting to order at 9:07 am.

Attorney General's Report:

Daniel Stowe read the Status and Activity Report. Mr. Stowe discussed Mobile Salons, and read 43-7-12, which states that a barber can only operate at the address on the license.

Further discussion on Mobile Salons was tabled to a later date.

Executive Session:

Winston Strickland moved, Lorena Barrios seconded, and the Board voted unanimously to enter Executive Session in accordance with O.C.G.A. χ 43-1-2(k) and 43-1-9(h) to deliberate on applications and enforcement matters and to receive information on applications and investigative reports. Voting in favor of the motion were, Charles Manning, Lutha Crump, Virgil Ergle, Winston Strickland, Lorena Barrios, and David Jones.

Lorena Barrios moved, Lutha Crump seconded, and the Board concluded Executive Session in order to vote on these matters and to continue with public session.

Lorena Barrios moved, Winston Strickland seconded, and the Board voted unanimously to waive the fee for CM to change the name of his school to Profile Institute of Barber-Styling.

Winston Strickland moved, Lorena Barrios seconded, and the board voted unanimously to approve endorsement for EA.

Winston Strickland moved, Lorena Barrios seconded, and the board voted unanimously to deny the application of LEH, and extend an invitation to the applicant to sit for the examination.

Winston Strickland moved, Virgil Ergle seconded, and the board voted unanimously to deny the application of TDF, and extend an invitation to the applicant to sit for the examination.

Winston Strickland moved, Lorena Barrios seconded, and the board voted unanimously to deny the application of BB and extend an invitation to the applicant to sit for the examination.

Charles Manning moved, Virgil Ergle seconded, and the board voted unanimously to deny the application of DDS/master barber licensure citing O.C.G.A § 43-1-19 as its authority to deny.

Lorena Barrios moved, Virgil Ergle seconded, and the board voted unanimously to approve the application of PDW/master barber endorsement attaching a consent order placing the license on four-year probation. The licensee must immediately report any future arrests or convictions to the board.

The Louisiana State Board requirements were discussed. **Charles Manning moved, Lorena Barrios seconded, and the board voted unanimously** to grant license to PH, from the last meeting, whose decision was tabled pending this information.
