The Board held a public hearing and discussed revision to its rules and considered modifications to Chapter 70-5, Rule# 70-5-.07 Pets

Lorena Barrios made a motion, Virgil Ergle seconded, and the Board voted unanimously to adopt these rules. In its consideration of the proposed rules, the Board stated that the formulation and adoption of these rules do not impose additional regulatory cost on any licensee that cannot be reduced by a less expensive alternative that fully accomplishes the objectives of the statutes that are the basis for the proposed rules. Further the Board stated that it is not legal or feasible to meet the objectives of these statutes to adopt or implement differing actions for business as listed in O.C.G.A. Section 50-13-4(a)(3)(A) (B)(C) and (D) and that the formulation and adoption of these rules will impact every licensee in the same manner and each licensee is independently licensed, owned, and operated and dominant in the field of Barbering.

70-5-.07 Pets. Amended.

- (1) Pets shall not be allowed in Barber establishments, except for guide and assistance dogs as permitted by Title 30 of the Georgia Code.

- (2) Each barbershop shall post in an open area, so as to be easily read by customers, a sign prohibiting pets.

Attorney General's Report
