1. In addition to all of the requirements for candidates for reciprocity found in Rule 130-8-.01, any person desiring to obtain a certificate of registration to engage in the occupation of cosmetology at the master cosmetologist, hair designer, esthetician or nail technician level, by reciprocity from another country where similar reciprocity is extended to this state and licensure requirements are substantially equal to those in this state, must furnish the following:

- (a) Transcripts of educational hours must be evaluated by a credential evaluation agency approved by the Board, to determine if the high school/GED and professional instruction is substantially equivalent to that of entry-level Georgia master cosmetologist, cosmetology instructor, esthetician, nail technician, or hair designer. The credentialing evaluation agency shall send its evaluation and a copy of the official transcript directly to the Board. A list of credentialing agencies approved by the Board shall be made available on the Board's website. The applicant will bear the financial responsibility for obtaining the credential evaluation.
