- Sherri Hobbs: Per her request, Sherri J. W. Hobbs of McDonough, Georgia, appeared before the Board along with her husband, Curtis Hobbs, and her attorney, Derrick Johnson. Initially, she insisted that she was licensed as Sherry Faye Hobbs; however, her identification did not match that of Sherry Faye Hobbs, CO084046. Secondly, she insisted that she has passed the examination in the past and should be licensed. Board records did not reflect that she has ever passed the examination for licensure. The Board questioned her concerning her August 18, 2004 arrest in which she was arrested at the PLB for Forgery in the First Degree. The police report reflected that she tried to renew Faye Leslie Hunt's license at that time. Ms. Hobbs stated that the charge was dropped because she had followed her attorney's advice at that time. The Board advised Ms. Hobbs that if she would take and pass the cosmetology examination, then she could reapply for a license.
