The Georgia State Board of Barbers met on September 13, 2010 at the Professional Licensing Boards, 237 Coliseum Drive, Macon, GA 31217.

Chairperson, David Jones established that a quorum was present and called the meeting to order at 9:05 a.m.

David Jones turned the chair over to Lisa Durden, Executive Director, for the purposes of voting.

David Jones made a motion, Virgil Ergle seconded and the Board voted unanimously to approve the minutes of the August 16, 2010 Board meeting.

The Board reviewed correspondence from the Technical College System of Georgia and viewed it as informational.

Virgil Ergle made a motion, Darrell Bullock seconded, and the board voted unanimously to dismiss citation for The Big Head Barber Shop, Statesboro.

Daniel Strowe, Assistant Attorney General gave a status and activity report including forty-five open cases and three closed cases. After suggested changes by Mr. Strowe , he gave the authority to post Board Rule 70-4-.06 Apprentices. Amended.

David Jones made a motion to post Board Rule 70-4-.06 Apprentices, Amended; Virgil Ergle seconded the motion. The Board voted unanimously to post the rule as follows:

70-4-.06 Apprentices. Amended.

- (1) A master barber shall not train more than one apprentice at any one time. ~~No barber shop shall have in training more than one apprentice at any time.~~
- (2) A barber shop shall not have more than three apprentices in training at any one time. ~~A licensed master cosmetologist, hair designer, nail technician, or esthetician shall not train a barber apprentice in a barber shop.~~
- (3) A licensed master cosmetologist, hair designer, nail technician, or esthetician shall not train a barber apprentice in a barber shop. ~~A barber apprentice shall be trained only by a master barber.~~
- (4) A barber apprentice shall only practice under the direct supervision of the master barber he or she is assigned to apprentice under on his or her apprentice license.

David Jones made a motion that the Board oppose any future legislative efforts for mobile barber shops for the following reasons:

1. The inspectors will not be able to conduct random inspections of the mobile shops to determine if the shops are in compliance with state laws and board rules including those with regard to licensure, sanitation, and disinfection.

2. Inspectors do not have the legal authority to stop a moving vehicle.
3. Shops cannot provide inspectors with a definite schedule.
4. Inspections could not be random; they would have to be scheduled in advance.
5. Barber shops must have a permanent address. O.C.G.A. §43-7-12(3) states:
“Does business only at the location shown on the application for licensure.”

Virgil Ergle seconded the motion, and the Board voted unanimously to oppose mobile barber shop legislation.

David Jones made a motion that the Board express its opposition to mobile barber shops for the following reasons:

- There can be no surprise factor for inspections;
- barber shops cannot provide inspectors with a definite schedule;
- barber shops are required to have a definite physical address; and
- inspectors do not have the legal authority to pull over a vehicle.

Virgil Ergle seconded the motion. Further discussion from the Board included that the mobile barber shops would have to meet all of the physical requirements for barber shops, including hot and cold running water and restrooms. The Board voted unanimously in favor of the motion.
