Richard Mullis made a motion to approve Board Rule 70-4-.06 Apprentices, Amended; Darrell Bullock seconded the motion. The Board voted unanimously to approve the rule as follows:

70-4-.06 Apprentices. Amended.

- (1) A master barber shall not train more than one apprentice at any one time. No barber shop shall have in training more than one apprentice at any time.
- (2) A barber shop shall not have more than three apprentices in training at any one time. A licensed master cosmetologist, hair designer, nail technician, or esthetician shall not train a barber apprentice in a barber shop.
- (3) A licensed master cosmetologist, hair designer, nail technician, or esthetician shall not train a barber apprentice in a barber shop. A barber apprentice shall be trained only by a master barber.
- (4) A barber apprentice shall only practice under the direct supervision of the master barber he or she is assigned to apprentice under on his or her apprentice license.
