Lisa Durden presented the DL Roope Pass/Fail report for January 1, 2011 through January 31, 2011. The Board viewed those reports as informational.

*A motion was made by David Jones, seconded by Virgil Ergle and the Board voted unanimously to enter Executive Session in accordance with O.C.G.A. §43-1-2(k) and 43-1-9(h) to deliberate on applications and enforcement matters and to receive information on applications and information received during the Hearings. Voting in favor of the motion were Darrell Bullock, Richard Mullis and Charles Manning.*

The Board concluded Executive Session in order to vote on these matters and to continue with public session.

### **Board Appearances**

Richard Mullis made a motion, Darrell Bullock seconded, and the board voted unanimously to overturn previous decision and approve application of C.C.B. – barber apprentice under a consent order with probation to run concurrent with criminal probation.
