The audit report submitted by the Department of Education regarding the audit of Paul Mitchell School of Atlanta was viewed as informational.

Tamela Hogan with Georgia Institute of Cosmetology and Esthetics schools asked if both schools were in 4800 square feet if they would need two restrooms for each area, or if three would be enough. Veronica Bivins made a motion that three for the facility would be adequate; Betty Carlisle seconded the motion. The Board voted that three restrooms would be adequate for the schools.
