- A.T.H.N. appeared before the Board to request the she be allowed to sit for the exam without the Master submitting or signing her apprentice hours. Veronica Bivins motioned the Board accept the unsigned apprentice hours and allow her to sit for the exam, Betty

Carlisle seconded and the Board voted to accepted the unsigned apprentice hours and allow her to sit for the exam.

- K.P.N. appeared before the Board to explain why she did not sign off on her apprentice's hours and why she had not submitted any hours for the apprentice. The Board had K.P.N. fill out and sign an estimated apprentice hours accumulated worksheet. The Board discussed a reprimand and referred to the Board Attorney as to what was in their authority to do regarding the Master.
- Steve Cagle and David Robinson with the Technical College System of Georgia and Peggy Braswell with Southeastern Technical College appeared before the Board to discuss changes in Rule 103-3.02 wording. The wording of "school hours" and "clock hours" poses issues to the Cosmetology, Instructor Training, Nail Care, and Esthetician curriculums. A solution of replacing with "credit hours" or simply "hours" was discussed.
- Ebony Holt, Program Associate and Tiffany Ferrell with Roosevelt Warm Springs Institute for Rehabilitation Georgia Department of Labor, appeared before the Board to discuss adding a cosmetology theory and limited training program without being considered a cosmetology school. The Board advised that Roosevelt Warm Springs Institute consider applying for a cosmetology salon license in order to be able to provide the limited training program and services that they are seeking.
- Kesha Harris Neely appeared before Board to appeal the denial of her Nail Technician reciprocity application. Veronica Bivins motioned to issue license if the required hours in Indiana meet the Georgia standards, Betty Carlisle seconded and the Board voted to issue license if the required hours in Indiana meet the Georgia standards.
