Board Chairperson Kay Kendrick instructed staff to schedule Allure Beauty School for a Board appearance. Penny Johnson made a motion to schedule Allure Beauty School for a Board appearance, DRee Church-Krohn seconded and the Board voted unanimously to schedule Allure Beauty for an appearance.

No further business was discussed and the meeting adjourned at 5:19 pm.
