T.S.P. (Master Cosmetology Reciprocity Application) - Georgia does not reciprocate with Washington. The Board recommended applicant must sit for the examination.

P.D. (Nail Technician Apprentice Application) The Board recommended to ratify licensure.

S.T.H. (Nail Technician Application) – The Board recommended approval without a fine.

P.B. (Nail Technician Apprentice Application) – The Board recommended approval without a fine.

A.K.T. (Nail Technician Apprentice Application) - The Board recommended approval with \$500 fine stating if the Salon pays the fine, applicant may request the Board waive the fine.

J.R.E. (Cosmetology Apprentice Application) – The Board recommended approval with a \$500 fine.
