Cosmetologists, hair designers, nail technicians, estheticians are also subject to the provisions of O.C.G.A. § 43-1-19.~~ Practitioners of the cosmetology profession in Georgia shall wear appropriate protective clothing and/or footwear at all times during the provision of ~~for~~ clinical services to prevent occupational exposure to potential infectious materials. Appropriate clothing and footwear may include, but not be limited to, clinical jackets, gloves and/or similar outer garments for the protection from infectious or harmful materials.
