### **Correspondence**

The Board reviewed correspondence received from Malinda Anderson, with the McEver Probation Detention Center, regarding suggestions on what the Department of Corrections could use to replace tweezers, nail files and nail clippers in the prisons. The Board suggested using smaller emery boards, disposable emery boards, and nail clippers with no nail cleaner attached, protective clippers with plastic covers, children implements, (Safety First).
