Executive Director's Report:

Deborah Beard, Executive Director updated the Board on Senate Bill 337. The Board was informed that as of April 29, 2014, Senate Bill 337 had passed.

The Board was also informed of the National Association of Barber Boards of America, 88th Annual Conference to be held in Las Vegas, Nevada, Beginning Sunday, September 14, 2014 and ending at noon on Thursday, September 18, 2014.

Executive Session:

Darrell Bullock motioned, Richard Mullis seconded and the Board voted unanimously to enter into executive session in accordance with O.C.G.A. §§ 43-1-2(k), 43-1-19(h), and 50-14-2(1), to deliberate on applications and complaint matters, and to receive information on applications, complaint reports, pending cases and the Assistant Attorney General's report.

At the conclusion of Executive Session David Jones declared the meeting to be “open” pursuant to the Open and Public Meetings Act O.C.G.A. § 50-14-1 et seq. No votes were obtained during the Executive Session.

Chairman David Jones called for the next order of business.

Darrell Bullock motioned, Richard Mullis seconded and the Board voted unanimously to accept the complaint recommendations.

Richard Mullis motioned, Virgil Ergle seconded, and the Board voted unanimously to accept the recommendations for the Legal Services Report.

Virgil Ergle motioned, Richard Mullis seconded, and the Board voted unanimously to accept the recommendations for the Applications/Supervisors Report.

Miscellaneous

Charles Manning motioned, Darrell Bullock seconded, and the Board voted unanimously to authorize staff to send proposed settlement orders to all licenses pending a citation hearing. The Board will not offer a reduced fine to any unlicensed activity including unlicensed persons or shops. However for all rule violations, the Board will offer in lieu of a hearing for the licensee to pay \$25.00 for each infraction and allow 60 days for payment of the fine or a citation hearing will be scheduled.

Richard Mullis motioned, Virgil Ergle seconde, and the Board voted unanimously to accept the status and activity report presented by the Assistant Attorney General, Stephanie Mason Zudekoff.
