### **RECIPROCITY REQUIREMENTS**

The Board continued discussion regarding the reciprocity requirements for applicants seeking licensure in Georgia. James Hutcheson motioned, Kay Kendrick seconded and the Board voted unanimously to accept the revised Georgia Reciprocity Requirements for Licensure as follows:

#### **Georgia Reciprocity Requirements**

In order to reciprocate into the cosmetology industry in Georgia, the following general requirements must be met:

1. Applicant's home state/country must extend similar reciprocity to Georgia.
2. The scope of practice for which the applicant is licensed in another state must be equal to or greater than the particular class of license that the applicant is applying for in the State of Georgia. To be licensed in this state in one of the occupations listed below, the scope of practice for which the applicant is licensed in another state must include the following:
  - Cosmetologist –hair designer, esthetics and nail technician responsibilities as listed below. (1500 cosmetology school hours)
  - Hair Designer – cut or dresses the hair, or singe and shampoo the hair or dye the hair. (1325 hair designer school hours)
  - Esthetics – massaging the face or neck, trimming eyebrows, dyeing eyelashes or eyebrows, or waxing, stimulating, cleansing, or beautifying the face, neck, arms, or legs of a person by any method with the aid of the hands or any mechanical or electrical apparatus or by the use of a cosmetic preparation skin care, facials, and cosmetic applications. (1000 esthetician school hours)
  - Nail Technician – trim, file, shape, decorate, apply sculptured or otherwise artificial nails, or in any way cares for the nails. (525 nail school hours)
  - Instructor - certified to teach within the cosmetology industry. (750 instructor school hours)
3. Applicant Master Cosmetologist and Hair Designer must have a minimum of required 75% of the above listed course hours and applicant must provide notarized proof of post licensing work experience for a minimum of two (2) years in reciprocating state.
4. Applicants for Esthetics and Nail Technician license must have a minimum of required 60% of the above listed course hours and applicant must provide notarized proof of post licensing work experience for a minimum of two (2) years in reciprocating state.
5. Applicant for Cosmetology, Hair Designer, Esthetician, or Nail Technician - must be at least 17 years of age with proof of high school diploma, general educational development (GED) diploma, or has a postsecondary education or college degree.
6. Applicant for Instructor – Must hold a GA Master Level License and must have a minimum of 75% of the required instructor course hours, and must provide notarized proof of post licensing work experience for a minimum of two (2) years in reciprocating state.
7. Applicant must have passed both a **written and practical national or Cosmetology State Board-approved** examination. If applicant **has not** taken both the written and practical portions of the exam, applicant will be required to sit for the missing portion of the exam.
8. Applicant must have taken the written and practical portions of the exam in English with no translator.

9. The applicant must have a **current, valid license in good standing** issued under the laws of another reciprocating state. Certification of licensures must be sent to Georgia from all states in which applicant has been licensed.
10. Georgia does not reciprocate with foreign countries. Foreign applicants may apply by exam and the Board will consider education, training, and experience on a case by case basis.
11. All other applications will be reviewed by the Board on a case by case basis.
