Policy #1 - For reciprocity applicants who are unable to obtain proof of language for their exams, the Board staff may rely on the applicant's answer to the question on the application: "Did you take both parts of the exam in English without the assistance of a translator? ___yes ___no ." when processing the application. If they took the exam in another language, the Board staff may administratively issue a letter of eligibility to sit for the exams in Georgia in English if they meet all other reciprocity requirements.

Policy #2- For states who do not give a practical exam, Board staff may administratively issue a letter of eligibility to sit for only the practical exam if the applicant meets all other requirements. States with no information on a practical: Florida and Nebraska.

Policy #3- For states whose practical exams are given by the schools, Board staff may accept those states as being in compliance with the Georgia requirement of having to have passed both a

written and practical exam. States identified as school giving the practical: Illinois, Indiana, and Rhode Island.

Policy #4 - For reciprocity applicants who state they are unable to provide proof of their high school diploma, GED, or college degree, the Board will accept their cosmetology training as proof of their “postsecondary” education.
