In light of the passage of House Bill 314 by the Georgia General Assembly and the possibility that this Board will cease to exist on June 30, 2015 and a new State Board of Cosmetology and Barbers shall come into existence on July 1, 2015 and regulate the practice of barbering in place of this Board, I move that the following shall be done:

- All application materials and records shall be released to the new board
- All examination materials and records shall be released to the new board
- All materials and records of deliberations of the Board with respect to applications and examinations shall be released to the new board
