Eyelash Extensions/Threading

David Jones made a motion, Dana Love seconded and the Board voted unanimously to request Lisa Durden, Division Director to compose a letter informing facilities of new law regarding eyelash extension/threading and advise a license must be obtained within sixty (60) days. Also compose a letter for facilities which notifies them of the new law that individuals must be licensed as an esthetician to provide eyelash extensions and licenses must be obtained by July 1, 2016. Inspectors can deliver these notifications at time of inspections.



The Georgia State Board of Cosmetology and Barbers will ratify the docketed Cease and Desist Orders at its next meeting after the date of docketing and include a list of the approved Orders in the Board minutes.
3. The Board authorizes the Executive Director to sign for the Board Chair with express permission upon receipt of signed Cease & Desist Orders.

4. The Board authorizes the Executive Director to sign for the Board Chair with express permission upon receipt of signed Consent Orders/Agreement unless otherwise directed. The Georgia State Board of Cosmetology and Barbers will ratify acceptance of the Consent Orders/Agreements at its next meeting and include a list of the approved Orders/Agreements in the Board minutes.

Attachment 2 – Endorsement

Proposed Rule – Certificate of Registration Endorsement

(1) An applicant for a certificate of registration by endorsement shall meet the following requirements before a certificate of registration may be issued:

(a) Submit a completed application for endorsement for the appropriate licensing level using the form furnished by the Board;

(b) Submit the required fee;

(c) Be at least 17 years of age;

(d) Hold a high school diploma, general educational development (GED) diploma, or a postsecondary or college degree;

(e) Be of good moral character; and

(f) Hold a license issued by another state or territory that is currently active, in good standing, and of the appropriate level for the type of license being applied for. If said license was issued by the other state or territory based on reciprocity or endorsement, applicant shall meet the additional requirements set out in paragraph (2)(a), (b), and (c).

(2) If the license held by the applicant was issued by the other state or territory based on educational and/or examination requirements that were less than the Board's current requirements for licensure by initial application for the appropriate licensing level, the applicant shall meet the following requirements in addition to those listed in paragraph (1):

(a) Hold at least the minimum education hours for the license type being applied for, as set out below:

1. Master Cosmetologist – 975 cosmetology school hours
2. Master Barber – 975 barber school hours
3. Hair Designer – 862 hair designer school hours
4. Barber II – 741 barber school hours
5. Esthetics – 600 esthetics school hours
6. Nail Technician – 300 nail care school hours
7. Cosmetology Instructor – 562 cosmetology instructor hours
8. Barber Instructor – 562 barber instructor hours
9. Hair Design Instructor – 562 hair design instructor hours
10. Esthetics Instructor – 375 esthetics instructor hours
11. Nail Care Instructor – 186 nail care instructor hours

(b) Have passed both a written and practical national or state approved examination in English; and

(c) If the applicant possesses less than the minimum number of education hours required for initial licensure for the appropriate license, the applicant shall have at least one year of post-license work experience in an area relevant to the license type.

Authority O.C.G.A. Secs. 43-10-2, 43-10-7, 43-10-9, 43-10-12.
