Georgia State Board of Cosmetology and Barbers

Administrative Approval to Lift Probation and Suspended Status Policy

The purpose of the policies set forth below is to authorize board staff to lift the probation or suspended status of licenses without presentation to the Board. The policies apply to licenses that were issued under a docketed consent agreement in which the licenses were placed on probation or suspended status, pursuant to O.C.G.A. §§ 43-1-19 and 16-13-111.

1. Administrative Approval to Lift Probation Status

- a. Required documents from Licensee
 - i. Official proof of discharge from parole or probation (i.e., Order of Discharge, Official Letter from Probation Office).
 - ii. Signed and notarized letter requesting the Board to lift probation status from the license.
- b. Compliance with Terms and Conditions of Docketed Consent Agreement
 - i. **Compliance.** After receipt of the required documents, board staff shall administratively approve a licensee's request to lift probation if there is no evidence or information that suggests Licensee violated the terms of the docketed consent agreement.
 - ii. **Noncompliance.** After receipt of the required documents, board staff may refer the licensee's request to lift probation to PLB Legal Services for presentation to the Board if there is any evidence obtained by the Board, board staff or investigations that question the licensee's compliance with the terms and conditions in the docketed consent agreement.

2. Administrative Approval to Lift Suspension Status

- a. Consent Agreements in which Suspension Status is lifted *Automatically* After Three (3) Months. Without request by the suspended licensee, board staff shall lift suspension status of a license three (3) months after the docket date of the consent agreement and change the status to "Active" or "Probation", depending on the terms of the docketed consent agreement.

- b. Consent Agreements in which Licensee Must *Petition* to Lift Suspension Status. Note: In previous consent agreements which suspended the license, pursuant to O.C.G.A. § 16-13-111, the licensee was required to submit a petition to the Board to lift suspension after three months of suspension status. This portion of the policies covers those consent agreements which are still in effect.
 - i. Required documents from Licensee
 - (1) Official proof of discharge from parole or probation (i.e., Order of Discharge, Official Letter from Probation Office).
 - (2) Signed and notarized letter requesting the Board to lift probation status from the license.
 - ii. Compliance with Terms and Conditions of Docketed Consent Agreement
 - (1) **Compliance.** After receipt of the required documents, board staff shall administratively approve a licensee’s request to lift probation if there is no evidence or information that suggests Licensee violated the terms of the docketed consent agreement.
 - (2) **Noncompliance.** After receipt of the required documents, board staff may refer the licensee’s request to lift probation to PLB Legal Services for presentation to the Board if there is any evidence obtained by the Board, board staff or investigations that question the licensee’s compliance with the terms and conditions in the docketed consent agreement.
