Kay Kendrick, Chairperson established a quorum was present and called the meeting to order at 3:07 p.m.

**APPROVAL OF AGENDA**

Betty Carlisle made a motion, Virgil Ergle seconded and the Board voted unanimously to approve the May 27, 2016 Agenda. The purpose of the meeting was to review and approve modifications to Proposed Rules previously (March) referred to the AG for a memo of authority.

Betty Carlisle motioned, Sarah Scott seconded and the Board voted unanimously to accept amendments to the Proposed Rule required for statutory authority:

- 240-2 Violations and Fines (modifications to various sections in the chapter)
- 240-3 Continuing Education (modifications required for statutory authority)

Jennifer Cheely recommended an update to 240-2-.02 (r) to match the wording of section 240-4-.03 to list all metal implements in the rule; Betty Carlisle motioned and Jennifer Cheely seconded and

the Board voted to unanimously accept the following amendment:

- 240-02-.02 (r) Failure to refrain from the use of any razor-type callus shavers designed and intended to cut growths of skin such as corns or calluses, eg., credo blades, razor-type callus shavers, cutters, scrapers, graters or anything that abrades or removes layers of skin. (Rule [240-4-.03](#) )

These amendments will be included in the Proposed Rules presented at the June 27, 2016 Proposed Rules Hearing. As there was no additional business before the Board, the Board Chair adjourned the meeting at 3:26 p.m.
