The Georgia State Board of Cosmetology and Barbers met on Monday August, 2016 at the Georgia Secretary of State, Twin Towers, 2 Martin Luther King, Jr. Drive, Plaza Level Suite 324, Atlanta GA 30334.

**OPEN SESSION – Part I – 9:44 A.M.**

Kay Kendrick established a Committee of the Board was present as provided for in O.C.G.A. 43-10-15 (b) and called the meeting to order at 9:44 a.m.
