The Board reviewed and discussed the Proposed Rules as follows:

- Rule – 240-16 – Esthetician School Equipment, Curriculum, And Instructor Training
- Rule – 240-17 – Nail Care School Equipment, Curriculum, And Instructor Training
- Rule – 240-18 – Hair Designer School, Equipment, Curriculum, And Instructor Training

### **PROPOSED RULES**

**Rule 240-14-.04 Barber Instructor Training Curriculum-** David Jones motioned, Jennifer Cheely seconded and the Board voted unanimously to adopt the proposed rule.
