#### BOXING COMMISSION MEETING MINUTES

Chairman Biello called the meeting to order at 11:00 am Tuesday March 13, 2007.

Commissioner Ichter made a motion to approve the minutes from the February 13, 2007 GAEC meeting. 2<sup>nd</sup> by Commissioner Hunnicutt and unanimous decision

Commissioner Ichter made a motion to approve the Lb 4 Lb Promotion's boxing event permit on June 1, 2007 in Gainesville, GA Second by Commissioner Hunnicutt, unanimously approved

Commissioner Hunnicutt made a motion to approve Austin Wingo's boxing event permit on June 2, 2007 at Center Stage in Atlanta, GA second by Commissioner Ichter, Unanimous Approval

Commissioner Hunnicutt made a motion to approve Randy Parker's promoter permit subject to investigation by Director Farr to other state licensing boards by which Mr. Parker is licensed. Commissioner Ichter 2<sup>nd</sup> the motion. Unanimous Approval

Commissioner Ichter made a motion to approve David Oblas' mixed martial arts event permit at Wild Bills in Atlanta, GA. 2<sup>nd</sup> by Commissioner Hunnicutt. Unanimous Approval

The following rules changes were discussed and proposed: Creation of complaint form and process, physicians will be assigned by the boxing commission, Promoters to provide to the commission a video/audio recording 10 days from event date, Increase fees for judges and timekeepers from \$100 to \$150, Elimination of 5% fee from purse amount to collection of 5% tax on gross proceeds called for by law, Creation of Amateur and Profession MMA Rules

Chairman JJ Biello requested that it be posted in minutes that the Commission has directed all promoters to follow the rules and laws of the State of Georgia regardless of any past practices and customs not supported by the rules and laws

Commissioner Ichter made a motion to approve the Lane Collyer's March 31, 2007 amateur mixed martial arts event permit at Georgia Mountain Center, Gainesville, GA 2<sup>nd</sup> by Commissioner Hunnicutt. Unanimous Approval

Commissioner Ector made a motion to approve Aaron Cooper's March 17 professional mixed martial arts event permit. 2<sup>nd</sup> by Commissioner Hunnicutt. Unanimous Approval

Commissioner Ichter made a motion to approve Scott Harper's March 17 amateur mixed martial arts event permit. 2<sup>nd</sup> by Commissioner Hunnicutt. Unanimous Approval

Chairman Biello offered recommendations to enhance the entertainment and sport of boxing

Commissioner Ichter made a motion to table proposed changes to ticket broker application until further investigation can be completed 2<sup>nd</sup> by Commissioner Moraetes Unanimous Approval

Promoter David Oblas was asked that the GAEC policy of having the final match of any event start by midnight of the event

Commissioner Ichter made a motion to adjourn the meeting. 2<sup>nd</sup> by Commissioner Hunnicutt. Unanimous Approval
