Motion to approve promoter's license renewal for Southeaster Fighting Championship, Fight Party Productions, Full Throttle Entertainment, and Undisputed Productions: Commissioner Biello made a motion, Commissioner Bloodworth seconded, and the Board voted unanimously to **approve**.

Motion to approve World Class Promoter's License and 8/15/09 Boxing match permit: Commissioner Biello made a motion to table the permit until the board could review the charges against, Commissioner Bloodworth seconded, and the board voted **unanimously to Table the application**.

Motion to approve Fight Party Productions 7/17/09 (Marietta) and Full Throttle Entertainment 7/25/09 match permit: Commissioner Ichter made a motion, Commissioner Bloodworth seconded, and the board voted **unanimously to approve**.

Motion to approve Southeastern Fighting Championship Event for 9/26/09 (Thomasville): Commissioner Bloodworth made a motion, Commissioner Biello seconded, and the Board voted unanimously to **approve**.

Discussion on the ABC Rules: The board was given a list by Commissioner Hunnicutt of ABC rules for officials that the board may look to adapt to its conduct for officials

Report on Professional Wrestling: Chairman Hunnicutt discussed what he observed at the 4/13/09 WWE event at Phillips Arena. It was concluded that the WWE has a well organized production. Commissioner Ichter discussed that the best way to regulate the wrestling organization was to look at a national regulation.

Motion to have Commissioner Ichter write a letter to Congressman Waxman asking to look into professional wrestling regulation: Commissioner Bloodworth made a motion, Commissioner Biello seconded, and the Board voted unanimously to **approve**.

Report on strikes in advanced amateur rule set to the head of Amateur MMA fighters: Executive Director Foster says that so far there have been no problems from this being enacted; however, more time is needed to get adequate data on the rule. Commissioner Biello made a motion to revisit the issue, Commissioner Bloodworth seconded, and the Board voted unanimously to **revisit the issue in September**.
