The Attorney general's representative stated that this would need to be in a rule. The issue was tabled until next commission meeting.

Motion to Approve Fight for Clarence Joseph vs. Darnell Boone Commissioner Kiker made a motion to deny, Chairman Biello seconded the motion. The commission voted 3-0 to deny.

Motion to lift suspension of Micah Goss Commissioner Geary made a motion to lift suspension and have Secretary Foster report the results to the commission after the fight. The Commission will re evaluate upon the report. Commissioner Kiker seconded the motion. The commission voted 3-0 to lift the suspension.

Motion to adjourn. Vice-Chairman Geary made a motion, Commissioner Geary seconded and the commission voted 3-0 to adjourn.

There being no further business to come before the Commission, the meeting was adjourned at 12:18 p.m.
