The Commission Meeting for the Georgia Athletic and Entertainment Commission was held on Thursday February 17, 2011, 2010 at The Sloppy Floyd Government Office Building 2 MLK Jr. Drive Atlanta, GA 30334.

Chairman Biello established that a quorum was present and the public hearing that was scheduled to begin at 11:00 a.m., was called to order at 11:07 a.m.

Motion to approve Commission Meeting Minutes of 1/20/2011 Commissioner Geary made a motion Commissioner Towns seconded the motion and the commission voted 4-0 unanimous to approve

Motion to approve event permit for Full Throttle Entertainment 3/11/2011 and 4/23/2011 pending the promoter sign the permit. Commissioner Geary made a motion, Commissioner Kiker seconded.

Motion to approve MOAB Promotions promoters license and event permit for 3/26/2011 Commissioner Towns motioned to approve, second by commissioner Geary. The commission voted 4-0 to unanimous approve.

Motion to Approve Event Permit for Bangkok Boxing

Commissioner Kiker made the Motion to approve the even permit for 3/25/2011
Commissioner Geary second the motion. The commission voted 4-0 for approval.

Motion to Approve an Event Permit for Atlanta Boxing Association 4/8/2011

Commissioner Geary motioned to approve the event permit with the condition that they increase their bond amount by as much as the purses for the fighters before the event, or the permit would be revoked, seconded by Chairman Biello. The commission voted 4-0 to unanimous approve.

Motion to post the Revised Kickboxing Rules with changes suggested by assistant attorney general Daniel Strowe. Commissioner Geary motioned to approve the event permit for 3/12/2011 and 3/13/2011, second by commissioner Kiker. The commission voted 4-0 to unanimous approve.

Motion to Approve Shannon Miller vs Tony Foster fight

Commissioner Towns made a motion to approve the promoter's license for approval of the match. Commissioner Kiker seconded the motion. The commission voted 4-0 to approve.

Motion to cease the investigation into the ticket broker who was selling tickets without a license based upon a request from the victim and a recommendation from the inspector generals office. Vice Chairman Geary made a motion, Commissioner Towns seconded and the commission voted unanimously to approve.

Motion to approve an investigation by the Secretary of State's investigations unit to launch an investigation into the Albany State unarmed combat violations.

Based on the fact that the GBI, and the Dougherty County District Attorney's Office have failed to launch and investigation and take action, Vice Chairman Geary made a motion to ask the Secretary of State's investigation unit to launch an investigation into the Albany State matter. Commissioner Towns seconded the motion. The Commissioner voted 4-0 to launch the investigation.

The commission directed Director Foster to write a letter to the Board of Regents explaining to them that unarmed combat is a violation of Georgia Law and to please educate the various Universities that fall under their jurisdiction.

Motion to adjourn. Commissioner Kiker made a motion, Commissioner Geary seconded and the commission voted 4-0 to adjourn.

There being no further business to come before the Commission, the meeting was adjourned at 12:22 p.m.
