Chairman Don Geary established that a quorum was present and the Georgia Athletic and Entertainment Commission meeting that were scheduled to begin at 11:00am and was called to order at 11:02am.

Motion to Approve the commission meeting minutes from April 16, 2015. Commissioner Rick Thompson makes a motion to approve. Commissioner J.J. Biello seconds, and the Commission votes 3-0 to approve.

Public Hearing and Vote on Rule 85-4-.07, Contestant's equipment. After no public comment was made, Chairman Geary makes a motion to approve the rule. Commissioner Biello seconds, and the Commission votes 3-0 to send to APA to finalize the rule change.

Discussion on illegal boxing at Déjà vu sports bar in Valdosta. Chairman Geary request that our executive director makes a police report with the county, and request that Reagan Dean create a Cease and Desist order. Commissioner Thompson makes a motion to have the Cease and Desist order typed up and sent over to the Secretary of State's investigations department. Chairman Geary seconds, and the Commission votes 3-0.

Discussion with Johnny Davis from the IKF. Mr. Davis wants to see if the Commission will turn over all amateur kickboxing to the IKF. Commissioner Thompson said legislation change would be required for that. Chairman Geary is willing to work with the IKF, but cannot grant Mr. Davis his wish of control over it.
