Report on Déjà vu Sports Bar in Valdosta. Executive Director Matt Woodruff informed the Commission that a Cease and Desist order was given to the owner of the club; however he did not sign it. The owner called Mr. Woodruff to inform him that they are no longer having fights. Mr. Woodruff informed that Commission that he has people in Valdosta on the lookout to see if fights continue. Mr. Woodruff considers this case closed.

Discussion on illegal boxing at Hush Nightclub in Waycross. Mr. Woodruff stated that fights were taking place in Waycross, that are very similar to the ones in Valdosta. Mr. Woodruff has already spoken to the owner of the club and the owner has said they are going to stop having the fights, as they did not know they were in violation of the law. Mr. Woodruff informed that Commission that he has people in Waycross on the lookout to see if fights continue. A report will be brought up at the July meeting to see if fights have stopped and if this case can be closed.
