The Commission Meeting for the Georgia Athletic and Entertainment Commission was held on Wednesday, November 18, 2015 at The Sloppy Floyd Government Office Building 2 MLK Jr. Drive Atlanta, GA 30334.

Commissioner Rick Thompson established that a quorum was present and the Georgia Athletic and Entertainment Commission meeting that were scheduled to begin at 11:00am and was called to order at 11:03am.

Motion to Approve the commission meeting minutes from October 14, 2015. Dr. Walter Young makes a motion to approve. Commissioner J.J. Biello seconds, and the Commission votes 5-0 to approve.

Request for Approval of the 12/5/2015 Undisputed Productions, LLC event permit. Commissioner Young makes a motion to approve. Commissioner Biello seconds, and the Commission votes 5-0 to approve.

Request for Approval of the 12/6/2015 Undisputed Productions, LLC event permit. Commissioner Young makes a motion to approve. Commissioner Biello seconds, and the Commission votes 5-0 to approve.

Public Hearing on Ben Brewer from the August 8th, 2015 No Show. Commissioner Thompson makes a motion to suspend Ben Brewer indefinitely, and must pay the promoter back \$2,130 for lost fees. If the fighter pays back the fee within 6 months, the suspension will be reduced to 6 months. Chairman Don Geary seconds, and the Commission votes 5-0.

Discussion on rule wavier from David Oblas. Mr. Oblas is asking to have a rule variance for him to allow using vinyl mats instead of canvas. Chairman Geary makes a motion to approve the wavier. Commissioner Young seconds, and the Commission votes 5-0 to approve.

David Oblas: Asked the Commission if we would consider a rule change for the fighting mat. Chairman Geary approved and make a motion that we start the rule change process. Commissioner Young seconds, and the Commission votes 5-0.
