The Board made a recommendation as to Respondent 1 to refer this case to the Attorney General's Office for a Consent Order assessing a \$500.00 fine and 24 months probation and as to Respondent 2 to close with letter of concern.

Derek Ryan Strother, Atlanta - The Board made a recommendation to accept the Consent Order due to convictions and place the license on probation for 24 months.

Mark Montfort, Lyons – This case involves allegations of unlicensed practice. The Board made a recommendation to accept the Cease and Desist Order and close case.

Christopher Ellis, Savannah - This case involves allegations of unlicensed practice. The Board made a recommendation to accept the Cease and Desist Order and close case.

LV110004 – The Board voted to amend the proposed Consent Order to now assess a \$500.00 fine, 24 months probation, and amend the language to include that respondent does not agree with allegations but agrees to the Consent Order.
