### **Minutes:**

Mr. Zimmerman requested that the Board table the Minutes from the May 03, 2007 and May 04, 2007 Board Meeting. Both sets of minutes will be reviewed during the June 15<sup>th</sup> Board Meeting, along with, the May 15, 2007 and May 16, 2007 Minutes.

**Mr. Earles moved, Ms. Lescak seconded and the Board voted to table the minutes from the May 03, 2007 and May 04, 2007 Board meeting until the next scheduled meeting.**

### **Executive Director's Report:**

1. Mr. Zimmerman updated the Board on the number of applications pending and approved to date: 888 licensed issued/1200 applications still pending.
2. Mr. Zimmerman discussed in great length his concern over the growing number of applications that are still pending due to the school approval process. Mr. Zimmerman offered several solutions to the Board in respect to finding a way to approve the schools in a more timely manner and issue the pending license during this "grandfathering" phase.
3. Mr. Zimmerman informed the Board that the NPEC will start informing/requiring any massage therapy education program applying for authority to operate in this state that they must meet or exceed the requirements set forth in Board rule 345-8.
4. Mr. Zimmerman reviewed an e-mail that was sent to the Board regarding a local municipality recently passing a local ordinance and is now charging a fee of \$600 to obtain a local business license. One of the requirements is applicants must appear in front of the Mayor and City Council and explain why he/she would like a business license. He/she also has to submit a list of surrounding businesses to the council, so that they could contact each business and give them the opportunity to refuse or grant a business license. Unfortunately, this board has no jurisdiction over local municipalities nor the issuance or denial of a business license.
5. Mr. Zimmerman updated the Board members regarding issuing a Cease and Desist Order to an unlicensed person.

**Board Policy Development:**

Due to the increasing number of pending applications (over 1200 to date), the majority pending due to the massage therapy programs/schools non-compliance with the approval process currently used by the Board, the Board has determined the need for a new policy. Following discussion, the Board determined that for each massage therapy education program/school that has a current NCBTMB provider number, and for those applicants graduating from that school who provided an official transcript verifying a minimum of five-hundred (500) hours and have met all other requirements of licensure, that licenses will be issued to them. This policy does not mean the massage therapy education program/school has been officially *recognized* by the Board as meeting or exceeding the requirements set forth in Board rule 345-8, just that during this initial eligibility phase, which, ends June 30, 2007, the Board has voted to adopt this policy. All pending school programs will continue to be processed to receive Board recognition as determined by the Board.

**Mr. Earles moved, Ms. Lescak seconded, and the Board voted to accept the above policy in order to issue licenses to those applicants pending school approval, who applied for licensure during the initial eligibility phase, having met all other requirements, and who are only being held up due to the program/school not complying or delaying the submission of information requested by the Board.**
